AMENDMENT TO COUNTY OF MENDOCINO AGREEMENT NO. BOS-23-171

This Amendment to Agreement No. BOS-23-171 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY", the MENDOCINO COUNTY TOURISM COMMISSION, a California non-profit mutual benefit corporation, hereinafter referred to as "MCTC", and CIVITAS ADVISORS, INC., a California corporation, hereinafter referred to as the "CONTRACTOR", on the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS-23-171 was entered into on September 1, 2023 (the "Initial Agreement"); and

WHEREAS, under Agreement No. BOS-23-171, CONTRACTOR provides services to COUNTY and MCTC is solely responsible for payment of all services rendered by CONTRACTOR to COUNTY; and

WHEREAS, upon execution of this document by COUNTY, MCTC, and CONTRACTOR, this Amendment will become part of the Initial Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY, MCTC, and CONTRACTOR to extend the termination date set out in the Initial Agreement from August 31, 2024 to June 30, 2025; and

WHEREAS, it is the desire of COUNTY, MCTC, and CONTRACTOR to increase the amount set out in the Initial Agreement by \$63,750 from \$76,500 to \$140,250.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the Initial Agreement is hereby extended from August 31, 2024 to June 30, 2025.
- 2. The total contracted amount set out in the Initial Agreement is hereby increased by \$63,750 from \$76,500 to \$140,250.

All other terms and conditions of the Initial Agreement shall remain in full force and effect.
