Re: Bower Limited Partnership streetscape concerns/comment submission for 11/4/2025 appeal hearing

Dear Mendocino County Board of Supervisors,

At 77 years old, I am a lifetime resident of and an advocate for Gualala. My sons and I own approximately 50% of the property affected by the Gualala Streetscape Project.

I've been the most enduring voice against the loss of on-street parking in downtown Gualala due to the upcoming Streetscape Project. My concerns have been summarily dismissed for decades. I'm now more worried than ever about what losing all on-street parking will do to our community. Imagine if none of the following vehicles could pull up on the side of the highway to park:

- fire engines and ambulances
- fishermen towing boats
- tree service trucks towing wood chippers
- contractors towing trailers
- utility and logging trucks
- motor homes and trucks towing travel trailers

If these vehicles have nowhere to park, then their drivers will not—CANNOT—spend money in our grocery stores, pizza shop, restaurants, galleries, or even go check their mail at the post office. Not to mention visitors with RVs or travel trailers having nowhere to park. Everyone in Gualala relies on tourism dollars. That's insane—do we really want to prevent people from supporting our local businesses? Gualala businesses, residents, and visitors depend on our existing on street parking. None of the parking lots downtown have turnaround space for these vehicles. Plus, if it's too difficult to park in a lot, people will just keep driving to find a place where they CAN park and they'll spend their money elsewhere.

As a property owner being impacted by the streetscape project, my family has had numerous conversations with Caltrans (which is the agency responsible for the streetscape project) and what we are being told is that the removal of on street parking is due to a requirement in the Gualala Town Plan (GTP).

Everyone knows that the GTP has many flaws that need to be addressed. In fact, the BOS stated to Gualala residents that it identified flaws in the GTP back when Redwood Coast Medical Servies was trying to get its helipad permitted. At that time the BOS committed to making the necessary changes to the outdated 23-year-old plan, but it has failed to do

so. The BOS approved the GTP on the premise that it met all the requirements of the California Coastal Act, including the Coastal Commission's policies. The GTP does not comply with the Coastal Commission's policies, and without on street parking our businesses will suffer greatly, and many businesses will be at risk of failing completely.

My commercial tenants don't own the land or buildings they occupy yet Caltrans and the Coastal Commission have not approached them to be part of the conversation about the negative financial impact these businesses will suffer from the theft of their customers' parking.

What is the BOS's plan to mitigate the financial losses of my tenant business owners?

As a result of the removal of on street parking it is likely that large trucks, motorhomes, emergency vehicles, and repair vehicles are going to double park or attempt to park in an unsafe manner in the small private parking lots. The BOS's GTP is causing the removal of the on-street parking and it is likely going to make the town less safe and less inviting. The BOS needs to immediately reevaluate its prohibition of on street parking in Gualala.

The Coastal Commission's website states as its mission that "the commission is committed to protecting and enhancing California's coast and ocean for present and future generations. It does so through careful planning and regulation of environmentally sustainable development, rigorous use of science, strong public participation, education, and effective intergovernmental coordination." As far as the Gualala Streetscape plan is concerned, the Coastal Commission is failing to live up to its mission statement, and it needs to address these issues with Caltrans and the people of Gualala before it is too late.

We need a Streetscape design that beautifies, is safe, and that retains on-street parking. We respectfully request that the BOS protect our community by denying this proposed project and we further request that it develop and adopt an updated Gualala Town Plan.
