

**RESOLUTION NO. 25-171**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 250038, MEMORANDUM OF AGREEMENT BETWEEN THE LITTLE RIVER AIRPORT PILOTS ASSOCIATION AND COUNTY OF MENDOCINO, REGARDING THE INSTALLATION OF A CEILOMETER AT LITTLE RIVER AIRPORT (LITTLE RIVER AREA)**

WHEREAS, the County of Mendocino operates and maintains an Automated Weather Observation System (AWOS) at Little River Airport (LLR), maintained under contract by DBT Transportation Services (DBT); and

WHEREAS, the Little River Airport Pilot Association (LLRPA) desires to upgrade the existing AWOS II to an AWOS III by the addition of a ceilometer; and

WHEREAS, the upgrade from AWOS II to AWOS III will increase the amount of information provided by the weather reporting system, and therefore contribute to the safety of flight for pilots using LLR;

WHEREAS, the LLRPA will pay for the purchase and installation of the ceilometer; and

WHEREAS, installing the ceilometer will not increase the maintenance cost through DBT; and

WHEREAS, the Federal Aviation Administration (FAA) has authorized the installation of the ceilometer.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors

1. Approves Department of Transportation Agreement Number 250038, Memorandum of Agreement Between the Little River Airport Pilots Association and the County of Mendocino; and
2. Authorizes and directs the Chair of the Board of Supervisors to execute said Agreement on behalf of the County of Mendocino.
