**COUNTY PROGRAMS OF LAST RESORT: PUBLIC ADMINISTRATOR, PUBLIC  
CONSERVATOR AND PUBLIC GUARDIAN**

**Discussion**

The Board of Supervisors welcomes this opportunity to respond to the Grand Jury report titled "County Programs of Last Resort: Public Administrator, Public Conservator and Public Guardian". Current Grand Jury procedures state: "[f]indings are the conclusions or judgements that logically flow from the verified facts." In that regard, the Board of Supervisors encourages the Grand Jury to focus on verified facts and avoid unsubstantiated opinions that tend to inflame instead of inform discussion of this critical issue.

**Pursuant to the request of the Grand Jury, the Board is responding to the following:**

- F3. When the status and conditions of all individuals are not shared with family members regularly, families become concerned about patients' welfare, especially if the patient is placed out-of-the area.

The respondent agrees with the finding.

- F4. The County is responsible to cover the costs of settling estates of those citizens that die without wills or relatives. The State assumes the remainder of assets with the County receiving only a small portion of the value of an estate. Most cases have minimal assets and the costs to the County are considerable.

The respondent agrees with the finding.

- F5. There are County general fund costs in all three programs. These costs appear to be mostly unknown to County taxpayers.

The respondent agrees with the finding. As of July 1, 2022, the Public Administrator and Public Guardian programs no longer receive County General Fund for the costs associated with these programs.

- F6. The high costs of hospitalizations for 5150 clients to the County justifies re-establishing a PHF with Measure B funds.

The respondent agrees with the finding.

**Response to Recommendations:**

- R3. The information regarding the three programs and their general fund costs be transparent and available to the public by inclusion in quarterly departmental reports to the BOS. (F4-F6)

The recommendation has been implemented.

Although the Public Conservator Behavioral Health programs do not receive General Fund dollars, they have been included in the CEO Report quarterly as of March 2023.
