and all subsequent amendments thereto, with the State of California for the purposes of the Grant.

SECTION 5:

If an application is approved, the Chief Executive Officer or designee*, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the Agreement for purposes of the Grant.
