Mendocino County Strategic Plan

In May 2022, the Mendocino County Board of Supervisors approved the first five-year strategic plan that will help guide the critical decisions the Board of Supervisors will face over the next five years with the ultimate goal of improving the quality of life for County residents. The CEO report will align with the 4 priority areas that include; An Effective County Government, A Safe and Healthy County, A Thriving Economy, and A Prepared and Resilient County.

Animal Services Agency

During the month of December 2023, **1** 3 cats and **1** 5 dogs were adopted, **1** 3 animals were returned to their owners and **1** 1 animals were transferred to other animal rescue organizations.

Child Support Services

The Mendocino County Department of Child Support Services is currently serving 2894 families to obtain financial and medical support.



Environmental Health

In 2023, the department initiated the tracking of counter traffic, providing valuable insights into trends, volume, and program utilization. In Ukiah, an average of 11 visits per day was recorded, with peak hours between 11 am - 2 pm.

Thursdays emerged as the least visited day. Analysis revealed that 60% of visits pertained to well and septic records, while 33% were related to food facilities. This data-driven approach provides crucial information for resource allocation and program improvement, ensuring the department remains responsive to the community's needs.

Executive Office - Contracts Unit

The Contract Unit collaborates directly with various County departments to implement contracts and amendments, ensuring compliance with County policy. Below are several notable highlights that illustrate an overview of the contracts unit in the year 2023.

- Administered review processes in Cobblestone, the County's electronic contract management software system, for over 2,200 contract items, including contracts, amendments, and Exceptions to Bid.
- Provided over fifteen individual or group trainings for staff across all County departments.
- Began the process of updating the County's amendment routing and tracking procedure to allow for increased efficiency. This process included updates to over 500 existing amendment records.

Health Benefits

IRS form 1095-C, Employer-Provided Health Insurance Offer and Coverage will be mailed to employees by January 31. This form communicates information about the health

insurance coverage offered to County employees who are full-time employees for one or more months of the calendar year. For general questions or if an employee did not receive their form, the employee can contact health benefits staff by emailing **employee health benefits**. For specific questions about the 1095-C form and tax filing, the employee should contact a tax professional.

Human Resources

The function of Human Resources involves managing the recruitment, development, well-being, and performance of government employees, while also ensuring compliance with regulations and promoting the efficient delivery of public services. Human Resources is happy to report the following updates:

<u>Retention Survey Results:</u> Mendocino County employees have the opportunity to give anonymous feedback at various stages of their employment: Upon hire, anniversary, and in the event of resignation or retirement. Look out for invitations from DecisionWise to make your voice heard.

<u>Wellness Incentive Program:</u> The Wellness Incentive Program for 2023 ended strong with a total of 459 employees completing the program requirements, which qualifies them for discounts in 2024 on their health care premiums.

<u>Spring Nourish Challenge (March 4th – April 14th)</u>: Registration opens in February for the 2024 Nourish Wellness Challenge.

<u>MCWOW Awards and Accolades:</u> The American Heart Association has awarded the County of Mendocino national Silver Award level recognition for its commitments to employee health and well-being as measured in the Association's 2023 Workforce Well-being Scorecard[™].

<u>Workforce Development Program:</u> There were 538 training seats filled by County employees across 109 trainings between July 1, 2023, and December 31, 2023. County employees can enhance their professional skills at a time convenient for them with online training.

Library

In 2023, after surveying the community and having community discussions at each branch, the Mendocino County Library has created a Strategic Plan to guide the process of carrying out the mission of the Library. The mission is to enrich lives through free and equitable access to materials and programs centered on education, culture, and entertainment. The Library is on track to complete many tasks in 2024 such as starting Library by Mail to provide services to homebound patrons, creating a new floating Spanish language collection, applying for grants to maximize funding, completing replacements of all computers 5 years or older at all branches, and expanding the number of hotspots in the popular lending program.

Mendocino County Department of Social Services



utilized the new O365 system to reorganize an old intranet system within a SharePoint Communication Site. This site acts as a department-wide communication platform also holding relevant documents, forms, and contacts DSS staff routinely access. Also, within the 2023 year, DSS Family & Children's Services (FCS) and Employment & Family Assistance Services (EFAS) launched

similar SharePoint Communication Sites with division-specific content. The launch of an Adults & Aging Services division site is slated for early 2024.

UC Cooperative Extension

The UC Cooperative Extension plays a vital role in the crop and livestock agricultural, forestry, and natural resources communities, aiding farmers and ranchers in enhancing their growing methods, addressing pest management issues, and promoting the development of livestock grazing crops and irrigation techniques that conserve water. Our 4-H Youth program builds future citizens and extends our science-based information with volunteer adults and teen leaders. Our volunteer programs, like Master Gardeners and California Naturalists increase our network of information providers. We also work in Community and Economic Development. With 64 offices spread across California, the University of California's Cooperative Extension serves as local hubs for solving agricultural and other challenges. Acting as a link between local concerns and the expertise of UC research, our county-based staff is deeply integrated into the community, residing and working in the areas they support.

The Animal Protection Unit worked **350** calls for service in December 2023, with **57** being categorized as a priority such as "biting animals,

cruelty complaints, animals in distress, aggressive loose animals and Law Enforcement assist."

Behavioral Health & Recovery Services

In 2023, Behavioral Health and Recovery Services achieved significant milestones in successfully implementing various programs catering to the needs of the vulnerable community they serve. Some noteworthy accomplishments include the following:

- Implementation of seven (7) youth prevention groups focused on empowerment and prevention.
- Implemented two (2) Spanish-speaking substance misuse treatment groups.
- Started three (3) evening SUDT groups for folks working.
- Opened two (2) mental health wellness centers (Willits & Ukiah).
- Implemented additional care management to assist individuals in supported living units to help with independent living.

Environmental Health

Throughout 2023, the Consumer Protection Team conducted a comprehensive total of 897 routine inspections, 45 pre-opening and re-inspections, and 21 plan reviews for permitted facilities. The Hazmat program celebrated significant achievements with 750 comprehensive inspections, covering critical areas such as Aboveground Petroleum Storage Act (APSA),

Underground Storage Tank Hazardous Materials Management Plans (UST HMMP), California Accidental Release Prevention (CalARP), and Hazardous Waste permits.

Library

According to the Food and Research Action Center, only 1 in 6 California children who qualify for free or reduced-price lunches receive summer meals. Lunch at the Library is a program funded by the CA State Library created to provide free

summer meals with library services to children in need. In 2023 two branches of the Mendocino County Library started participating in coordination with local meal providers. In the summer of 2024, five library branches including Ukiah, Fort Bragg, Coast Community, Round Valley, and Willits, will be participating! Fun and educational activities and games are provided by library staff for the students who attend lunch at the library.

Museum

The **Behind the Scenes Tour** series contributes to a safe and healthy community by providing access to a variety of Museum collections that are not currently on

display. This unique tour series brings together diverse community members and encourages connection and discussion about Mendocino County History. The **Coffee Break** Registration is the first event in an ongoing series of programs designed to encourage volunteerism at the Museum and invite participation in the interpretation and preservation of the Museum collections. This program series contributes to a Safe and Healthy Community by providing an opportunity to meet new people and to contribute talents and skills with the community.



Public Health

The primary goal of the Department of Public Health is to safeguard and promote the health and well-being of the residents of Mendocino County, in partnership with the community. Throughout the challenging COVID-19 pandemic in 2023, various divisions within

Public Health, such as Public Health Emergency Preparedness, Mendocino County Adolescent Health, Communicable Disease and Immunizations, and more, diligently carried out their responsibilities.

During the month of December 2023, **514** dog licenses and **52** non-commercial kennel licenses were sold resulting in **\$25,388** in revenue.

Child Support Services

A total of \$431,446.75 in court-ordered child support was collected and distributed in the month of December. There are 711 dependent children receiving medical coverage.



Economic Development

The Economic Development Division is a new division of the Executive Office as of October 2023. To focus our efforts effectively, we studied past reports and plans, the General Plan, and the Board's Strategic Plan. We met with other county

divisions, government agencies, organizations, and stakeholders to gain situational awareness. Identified key priorities for economic development in Mendocino County are housing (market rate and affordable), workforce development, living wage job creation, and infrastructure development and resiliency, all with climate awareness and equitable opportunity in focus.

Two Animal Protections Officers attended the PC 832 Firearms course at the Santa Rosa Community College Law Enforcement Training

Center in Windsor, CA in early December 2023. The course is a requirement under the State of California for Animal Control & Animal Protection Officers that authorizes officers to carry firearms and chemical immobilization guns.

These incidents showcased the team's proficiency in managing and mitigating hazardous material emergencies. Moreover, the Hazmat program proactively contributed to community safety by offering essential training sessions for local fire agencies and first responders on responding to hazardous material incidents and preparing for emergencies.
