

**THIRD AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 21-183**

This third Amendment to BOS Agreement No. 21-183 is entered into this 14th day of March, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Redwood Community Services, Inc.**, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 21-183 was entered into on July 1, 2021; and

WHEREAS, first Amendment BOS Agreement No. 21-183-A1 was entered into on June 7, 2022; and

WHEREAS, second Amendment BOS Agreement No. 21-183-A2 was entered into on August 2, 2022; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in second Amendment BOS Agreement No. 21-183-A2, from December 31, 2022 to June 30, 2023.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in second Amendment BOS Agreement No. 21-183-A2 is hereby extended from December 31, 2022 to June 30, 2023.

All other terms and conditions of BOS Agreement No. 21-183 shall remain in full force and effect.
