

## **RESOLUTION NO. 25-120**

### **RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS PURSUANT TO CALTRANS/CALIFORNIA HIGHWAY PATROL'S JOINT POLICY GUIDELINES FOR SPECIAL EVENTS ON STATE CONVENTIONAL HIGHWAYS IN ORDER TO OBTAIN A PERMIT FROM CALTRANS FOR THE ELK VOLUNTEER FIRE DEPARTMENT'S "GREAT DAY IN ELK" PARADE, TO BE HELD IN ELK, CALIFORNIA, ON SATURDAY, AUGUST 23, 2025**

WHEREAS, the Elk Volunteer Fire Department in the community of Elk wishes to hold a parade in connection with the "Great Day in Elk" celebration; and

WHEREAS, said parade will be held from 12:00 p.m. until 1:00 p.m. on August 23, 2025, commencing at Harbor House and proceeding south on State Highway One to Louisa Street; and

WHEREAS, it will be necessary to impose controlled traffic (one lane) on Highway One from post mile marker 34.65 to post mile marker 34.0; and

WHEREAS, the Elk Volunteer Fire Department has agreed to cooperate fully with State and local agencies to adequately mitigate traffic flow.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby support the "Great Day in Elk" Parade and seeks the support and cooperation of any involved agencies.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors does hereby state that any liabilities and responsibilities shall rest with the parade sponsors.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors hereby requests the State Department of Transportation to give their permission, pursuant to the Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Highway Rights-of-Way, for the Elk Volunteer Fire Department to hold the 2025 "Great Day in Elk" Parade on State Highway One.

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors will forward copies of this Resolution to the District Permit Engineer, Department of Transportation (Eureka), the California Highway Patrol, and the Elk Volunteer Fire Department.
