RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 250012, PROFESSIONAL SERVICES AGREEMENT WITH MGE ENGINEERING, IN THE AMOUNT OF \$628,952.62 FOR CONSTRUCTION MANAGEMENT SERVICES FOR THE TERM STARTING UPON EXECUTION OF THE AGREEMENT THROUGH JUNE 30, 2027, AND AUTHORIZING AN ADDITIONAL CONTINGENCY AMOUNT OF \$63,000 FOR THE LAMBERT LANE BRIDGE REPLACEMENT OVER ROBINSON CREEK, COUNTY ROAD 123A (BOONVILLE AREA)

WHEREAS, the Mendocino County Department of Transportation (DOT) desires to construct a new concrete and steel bridge over Robinson Creek on Lambert Lane, County Road (CR) 123A, Mile Post (M.P.) 0.10, on the same alignment; and

WHEREAS, the costs of construction of the Lambert Lane Bridge Replacement Project over Robinson Creek are anticipated to be paid for by the Federal Highway Administration (FHWA) Highway Bridge Program (HBP) with the local match funded with Toll Credits; and

WHEREAS, funding to accommodate construction costs has been budgeted through Budget Unit (BU) 3041 (Fiscal Year (FY) 2024/25 and FY 2025/26); and

WHEREAS, there is a need for construction management services for the construction phase of the project; and

WHEREAS, DOT has insufficient engineering staff to perform the work in a timely manner and therefore requires professional, expert, and technical services of a temporary nature; and

WHEREAS, DOT underwent a qualification based selection process to find a consultant who can perform the construction engineering work meeting the requirements of FHWA; and

WHEREAS, MGE Engineering has provided a satisfactory proposal indicating that they will perform the required work under DOT Agreement No. 250012 within the stipulated time frame for a not-to-exceed amount of \$628,952.62, and DOT determined that MGE Engineering is the firm best qualified to perform the required work; and

WHEREAS, DOT believes it is expedient for amendments authorizing contingencies under DOT Agreement No. 250012 in the amount of \$63,000 for additional amendments to address unanticipated items of work that may arise during construction to be executed by the Director of Transportation, so as to allow for timely completion of the work.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors:

- 1. Approves DOT Agreement No. 250012, Professional Services Agreement with MGE Engineering for completion of construction engineering services; and
- 2. Authorizes and directs the Chair of the Board of Supervisors to execute said DOT Agreement No. 250012 on behalf of Mendocino County; and

3. Authorizes the Director of Transportation or his designated representative to sign any and all amendments to this agreement that will not result in an increase cost beyond the amount specified above.
