RESOLUTION NO. 18-02

RESOLUTION OF THE MENDOCINO COAST RECREATION AND PARK DISTRICT BOARD OF DIRECTORS APPROVING A REQUEST TO THE MENDOCINO COUNTY BOARD OF SUPERVISORS FOR THE LOAN OF A PORTION OF THE ANTICIPATED 2018-2019 PROPERTY TAX REVENUE.

WHEREAS, the Mendocino Coast Recreation and Park District ("District") is a recreation and park district duly organized and existing under and pursuant to the constitution and laws of the State of California; and

WHEREAS, the District receives from the County of Mendocino annually a portion of the property taxes collected by the County for residents within the District's boundaries; and

WHEREAS, section 23010 of the California Government Codes provides that a county may temporarily loan available funds from the county treasury to a special district, in order to enable the district to perform its functions and meet its obligations, by a resolution adopted by its board of supervisors; and



WHEREAS, the District desires a temporary loan of funds for the purpose of meeting its obligations in an amount of \$30,000 from the projected property tax revenue for the fiscal year 2018-2019, and the balance of the loan shall be repaid out of said revenue prior to payment of any other obligations;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Mendocino Coast Recreation and Park District: Request for the Board of Supervisors of the County of Mendocino and the County Treasury, transfer a portion of the anticipated property tax revenue for the fiscal year 2018-2019, to the Mendocino Coast Recreation and Park District, in accordance with the California Government Code 23010, in an amount of \$30,000 from the projected property tax revenue for fiscal year 2018-2019. Copies of this resolution shall be provided to the County of Mendocino Auditor and Treasurer.
