RE: ADOPTION OF RESOLUTION AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 240002 TO PERFORM THE 2024 CORRECTIVE/PREVENTATIVE MAINTENANCE PROJECT ON MOUNTAIN VIEW ROAD AT AN ESTIMATED COST OF \$7,400,000 (MANCHESTER/BOONVILLE AREA)

Honorable Board Members:

This Department of Transportation (DOT) Contract Number (No.) 240002 will provide for road pavement preservation strategy of double chip seal treatment the entire length of the roadway, as well as potentially "3R" (resurfacing, restoration, and rehabilitation) work with asphalt overlays and/or full depth reclamation (FDR) on portions of the road.

The base bid (estimated \$5,400,000) of this project is to be funded through Senate Bill 1 (SB 1): The Road Repair and Accountability Act of 2017, and Road Maintenance and Rehabilitation Account (RMRA) funds, with the potential "3R" work funded through the State Transportation Improvement Program (STIP). The program year for the STIP funds has not yet been determined, so the "3R" work will only be awarded if the STIP funds are allocated in State Fiscal Year (FY) 2024/25. The Department will not exceed funding available. This 2024 Corrective Maintenance Project constitutes Year 6 (FY 24/25) of the 20-year Annual Project Expenditure Plan as outlined in my January 8, 2019, Director's Report, which provides for corrective/preventative maintenance on the County road listed above.

DOT intends to advertise for bids and have this project completed this calendar year. DOT will prepare construction plans, specifications, estimates, and contract documents; advertise and award the County contract; and coordinate the project with the other governmental agencies.

I recommend and request that the Board authorize and direct the Director of Transportation to advertise for construction bids and to award DOT Contract No. 240002 up to \$7.4M, to perform the 2024 Corrective/Preventative Maintenance Project on Mountain View Road. Total distance to be treated is estimated to be 24.58 miles, but the distance treated could be adjusted depending on bids received. If needed, reductions in miles of roadway treated will be made. Bid additives have been included for full depth reclamation on portions of the road and asphalt overlays on certain sections of the road. All bid additives are dependent on available funds and bid totals.

The Director is also making an Assembly Bill 720 declaration, that DOT crews will do approximately \$750,000 in preparation (dig outs) and pavement marking for this corrective maintenance project (DOT Contract No. 240002), as well as additional crew efforts this year on corrective maintenance.

Department of Transportation staff personnel have prepared a draft Resolution which provides said authorization for the Board's consideration and adoption.
