AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. <u>15-071</u>

This Amendment to BOS Agreement No. 15-071 is entered into this 1974 day of 1975, 2019, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and COLD CREEK COMPOST, INC., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 15-071 was entered into on July 7, 2015; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>COLD CREEK COMPOST, INC.</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to replace Section 13 set out in the original BOS Agreement No. <u>15-071</u> in its entirety; and

NOW, THEREFORE, we agree Section 13 shall be replaced to read as follows:

1. 13. Effective March 19, 2019, Cold Creek shall charge County Franchisees \$36.00 per ton for Mixed Organic Waste, adjusted up or down on each subsequent January 1 by a percentage factor equal to 0.9 of the change of the All Urban Consumers Consumer Price Index (CPI-U), all items, for the San Francisco-Oakland-San Jose, CA, Base Period 1982-1984 = 100, not seasonally adjusted, compiled and published by the U.S. Department of Labor, Bureau of Labor Statistics or its successor, and its value twelve months before.

All other terms and conditions of BOS Agreement No. <u>15-071</u> shall remain in full force and effect.
