

**AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. 24-062**

This Amendment to Agreement No. 24-062 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and DFM Garage Inc., dba DFM Auto Repair, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. 24-062 was entered into on May 7, 2024; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date set out in Agreement No. 24-062, from June 30, 2024 to June 30, 2025; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total contracted amount set out in Agreement No. 24-062 from fifty thousand dollars (\$50,000) to two hundred thousand dollars (\$200,000).

NOW, THEREFORE, we agree as follows:

1. The termination date set out in Agreement No. 24-062 is hereby extended from June 30, 2024 to June 30, 2025.
2. The total contracted amount set out in Agreement No. 24-062 is hereby increased from \$50,000 to \$200,000.

All other terms and conditions of Agreement No. 24-062 shall remain in full force and effect.
