

RESOLUTION NO. 18-068

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE CALIFORNIA COASTAL COMMISSION TO PROCESS A CONSOLIDATED COASTAL DEVELOPMENT PERMIT FOR THE CALIFORNIA DEPARTMENT OF TRANSPORTATION TO IMPLEMENT THE INTERIM LEAD CONTAMINATION MITIGATION MEASURES PROJECT ON HIGHWAY ONE AT 2801 SPRING GROVE ROAD (APNS 123-360-06 AND 123-340-01)

WHEREAS, Section 30601.3 of the Public Resources Code allows for a consolidated permitting process for projects for which the Coastal Development Permit (CDP) authority is shared by a local government and the California Coastal Commission (Commission); and

WHEREAS, in order for the Commission to process and act upon a consolidated CDP application, Section 30601.3 of the Public Resources Code requires that the applicant, the local government and the Commission consent to the consolidation, provided that public participation is not substantially impaired by the consolidation; and

WHEREAS, the implementation of the interim lead contamination mitigation measures project is under the coastal development permit authority of both Mendocino County and the Commission and would otherwise require a coastal development permit from both Mendocino County and the Commission for the portions of the project located within each jurisdiction; and

WHEREAS, the project is time critical to provide remedial measures to minimize recreational user exposure to lead impacted soil on private property located beneath and adjacent to the Salmon Creek Bridge on State Route 1 at 2801 Spring Grove Road (APNs: 123-360-06 and 123-340-01) in Mendocino County and to prevent further exposure and tracking of lead contaminated soils into the private residence; and

WHEREAS, public participation will not be substantially impaired as the Commission will hold a public hearing on the project, allowing interested parties to submit timely comments to the Commission and/or attend said hearing, and which consolidated permit process will allow for this project to be evaluated in its entirety.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors authorizes the California Coastal Commission to accept and process a consolidated Coastal Development Permit from the California Department of Transportation to implement interim lead contamination mitigation measures at 2801 Spring Grove Road (APNs 123-360-06 and 123-340-01).

The foregoing Resolution introduced by Supervisor Brown, seconded by Supervisor Crosky, and carried this 8th day of May, 2018, by the following vote:




