

**FOURTH AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 23-042**

This Fourth Amendment to BOS Agreement No. 23-042 is entered into this 10th day of September, 2024, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and KRONICK, MOSKOVITZ, TIEDEMANN & GIRARD, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 23-042 was entered into on 3/28/23 (the "Initial Agreement"); and

WHEREAS, Amendment to BOS Agreement No. 23-043-A1 was entered into on 10/31/23 (the "First Amendment") increasing the total amount by \$200,000 for a new total of \$400,000; and

WHEREAS, Amendment to BOS Agreement No. 23-043-A2 was entered into on 3/12/24 (the "Second Amendment") increasing the total amount by \$300,000 for a new total of \$700,000; and

WHEREAS, Amendment to BOS Agreement No. 23-043-A3 was entered into on 6/25/24 (the "Third Amendment") increasing the total amount by \$700,000 for a new total of \$1,400,000; and

WHEREAS, the Initial Agreement, First Amendment, Second Amendment and Third Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and KRONICK, MOSKOVITZ, TIEDEMANN & GIRARD, this third amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount payable from \$1,400,000 to \$2,000,000.

NOW, THEREFORE, we agree as follows:

1. The total amount payable set out in the Agreement will be increased from \$1,400,000 to \$2,000,000.

All other terms and conditions of Agreement shall remain in full force and effect.
