

**AMENDMENT NUMBER 5 TO DEPARTMENT OF TRANSPORTATION AGREEMENT NO. 190094 / BOARD OF SUPERVISORS AGREEMENT NUMBER 20-015, STANDARD SERVICES AGREEMENT WITH O'NEIL'S SEPTIC SERVICE, FOR LEACHATE MONITORING AND HAULING SERVICES FOR SOUTH COAST LANDFILL, FOR THE TERM ENDING JUNE 30, 2024**

This Amendment to Agreement Number (No.) 5 to Department of Transportation (DOT) Agreement No. 190094 / Board of Supervisors (BOS) Agreement No. 20-015 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and O'Neil's Septic Service, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, DOT Agreement No. 190094 / BOS Agreement No. 20-015 was entered into on February 25, 2020, for leachate monitoring and hauling services for South Coast Landfill; and

WHEREAS, Amendment No. 1 to DOT Agreement No. 190094 / BOS Agreement No. 20-015 (DOT Agreement No. 190094 A1) was entered into on October 7, 2020, Amendment No. 2 (BOS Agreement No. 20-015-A1) on July 20, 2021, Amendment No. 3 (DOT Agreement No. 190094 A3) on April 25, 2022, and Amendment No. 4 (BOS Agreement No. 20-015-A2) on July 11, 2023; and

WHEREAS, upon execution of this document by COUNTY and CONSULTANT, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, due to higher than anticipated rainfall, additional funds are needed to perform the leachate monitoring and hauling services through the remainder of the Agreement term.

NOW, THEREFORE, we agree as follows:

1. The total contracted amount set out in Agreement No. DOT Agreement No. 190094 / BOS Agreement No. 20-015 is hereby increased from \$93,000 to \$133,000.

All other terms and conditions of DOT Agreement No. 190094 / BOS Agreement No. 20-015 shall remain in full force and effect.
