## AMENDMENT TO COUNTY OF MENDOCINO AGREEMENT NO. PA #23-113

This Amendment to Agreement No. <u>PA #23-113</u> is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "Receiving County," and COUNTY OF LAKE, a political subdivision of the State of California, hereinafter referred to as "Sending County," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. PA #23-113 was entered into on June 20, 2023; and

WHEREAS, upon execution of this document by Receiving County and Sending County, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of Receiving County and Sending County to extend the termination date set out in the original Agreement No. <u>PA #23-113</u> from <u>June 30, 2024</u> to June 30, 2025; and

WHEREAS, it is the desire of Receiving County and Sending County to increase the maximum cost to Sending County in fiscal year 2023-24 in the original Agreement No. PA #23-113 from Twenty-Five Thousand Dollars (\$25,000) to One Hundred Thousand Dollars (\$100,000); and

WHEREAS. it is the desire of Receiving County and Sending County to increase the total contract amount from June 20, 2023 to June 30, 2025 set out in Agreement No. <u>PA #23-113</u> from <u>Twenty-Five Thousand Dollars</u> (\$25,000) to <u>Two Hundred Thousand Dollars</u> (\$200,000).

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in Agreement No. <u>PA #23-113</u> will be extended from <u>June 30, 2024</u> to June 30, 2025.
- 2. The maximum cost to Sending County in fiscal year 2023-24 in Agreement No. PA #23-113 will increase from Twenty-Five Thousand Dollars (\$25,000) to One Hundred Thousand Dollars (\$100,000).
- 3. The total contract amount from June 20, 2023 to June 30, 2025 set out in Agreement No. <u>PA #23-113</u> will be increased from <u>Twenty-Five Thousand</u> Dollars (\$25,000) to Two Hundred Thousand Dollars (\$200,000).

All other terms and conditions of Agreement No. PA #23-113 shall remain in full force and effect.
