**SECOND AMENDMENT TO COUNTY OF MENDOCINO  
AGREEMENT NO. 22-038**

This second Amendment to Agreement No. 22-038 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **STONE CREEK ENVIRONMENTAL CONSULTING, LLC**, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. 22-038 was entered into on February 8, 2022 (the "Initial Agreement"); and

WHEREAS, First Amendment to Agreement No. 22-038 was entered into on February 11, 2025 (the "First Amendment") extending the termination date from December 31, 2024 to December 31, 2025; and

WHEREAS, the Initial Agreement and First Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this second Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from December 31, 2025 to December 31, 2026.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from 12/31/2025 to 12/31/2026.

All other terms and conditions of the Agreement shall remain in full force and effect.
