 As I was in the ambulance, the "big one" happened and she was completely prepared to use her skills.
- I was not a good patient, mainly because of the extreme pain. I'm anxious to see her again and apologize for my inability to follow her requests, but her professionalism saw past my obnoxiousness, and she did her job. I'm very appreciative. I learned a life lesson .
- Within 90 minutes of the attack, a cardiologist had performed the necessary surgery and I was treated and saved

Aiden suffered major injuries, including a broken femur and severe soft tissue damage to his left foot and leg.

Aiden underwent extensive surgery on his leg resulting in a rod and 7 screws inserted into his femur. Aiden also required plastic surgery on his leg/ foot to repair the tissue and nerve damage.





Aiden Now

- The EMTs, paramedics, and fire crews that day took a hold of a horrible situation and made it so much better. From an emotional perspective the first responders kept Aiden calm as he laid on the ground. They even kept me calm. They managed a crowd that seemed to be forming, all while treating the medical needs of my child.
- They NEVER left my son's side.
- The tissue damage was severe enough that one of the main tendon's responsible for walking/moving foot and leg was exposed. The tendon was not damaged and stayed intact due to the quick response of the first responders.
- Aiden has recovered well almost. We are working on the limp, and he is waiting for the day he can reunite with his skateboard..
 BUT with weekly physical therapy and within just 12 weeks this son of mine is already walking.



Meet Kaden

- Kaden was run over by a tractor
- He had severely bruised lungs, bilat pneumothorax's, several fractures including a femur and a lacerated spleen
- Kaden's condition is listed as very critical condition










 Kaden underwent multiple surgeries, extensive hospital stay, and rehabilitation





2020 Fire Agency Call Breakdown






2020 Fire Department Call type Breakdown

Long-term (5-years) sustainable funding toward information and communication technologies (currently we use the Image Trend data platform for our Patient Care Reporting, License Management System and Resource Bridge Disaster Management programs)

Implementation of Pulse Point in Mendocino County

Funding for mission-critical equipment and supplies (cardiac monitors, PPE, Epi Pens and ambulance purchases)
