AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 23-026

This Amendment to BOS Agreement No. <u>23-026</u> is entered into this 5th day of Dec , 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>MAGELLAN HEALTH SERVICES</u> <u>OF CALIFORNIA, INC. EMPLOYER SERVICES</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 23-026 was entered into on February 28, 2023; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>23-026</u>, from <u>January 1, 2024</u> to <u>June 30</u>, <u>2024</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to add the amount of Fifty Thousand Dollars (\$50,000), for a revised total Agreement amount of One Hundred Twenty-Two Thousand Dollars (\$122,000).

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>23-026</u> will be extended from January 1, 2024, to June 30, 2024;
- 2. BOS Agreement No. <u>23-026</u> is to be increased by the amount of Fifty Thousand Dollars (\$50,000) for services to be provided in fiscal year 23/24 for a revised contract total of One Hundred Twenty-Two Thousand Dollars (\$122,000).

All other terms and conditions of BOS Agreement No. <u>23-026</u> shall remain in full force and effect.
