Mendocino County Board of Supervisors Sonoma Clean Power Joint Powers Authority Invitation August 1, 2016

At the July 26, 2016 meeting of the Point Arena City Council, I was authorized to sign a letter indicating our support for the Board of Supervisors formally declaring its interest in joining the Sonoma Clean Power Joint Powers Authority.

Sonoma Clean Power has five goals. They are:

- 1. To seek to reduce the greenhouse gas emissions associated with electricity used by its customers.
- 2. To seek to increase the use of renewable energy resources.
- 3. To benefit the area's local economy through investment in local infrastructure, projects and energy programs.
- 4. To manage a diverse resource portfolio to increase control over energy costs and maintain competitive and stable electric rates.
- 5. To help customers reduce energy costs through investment in and administration of enhanced customer energy efficiency, distributed generation, and other demand reducing programs.

The potential to bring these benefits to the ratepayers of Point Arena is very attractive but cannot occur unless the Board of Supervisors takes action on August 2. It is our understanding that delay at this point will push the program back at least one year.

The popularity of Community Choice Aggregation (CCA) is growing rapidly in California with estimates that within the next five years, 50 percent of California counties will be served by alternative energy agencies—local agencies formed to provide electricity to homes and businesses at better rates and with more renewable energy options than PG&E. In our region, both Sonoma Clean Power and Marin Clean Energy have clearly demonstrated the viability of this new model. It's time to offer this model to ratepayers in Mendocino County.
