## **Mendocino Coast Hospital Foundation – Winesong**

### **Supplement to the Application for Outdoor Festival License - 2016**

#8. This is the 32<sup>nd</sup> year that Winesong is being held at the Mendocino Coast Botanical Gardens, 18220 Highway One, Fort Bragg, CA 95437. A map of the Garden area to be used is attached. Adjoining (approximately 1/2 acre) property of Joe Moura Construction Co. will be used for parking; as well as Bill Patton's property on Del Mar Drive, .2 mile west of Hwy One; and .3 mile north of Hwy One & Hwy 20 intersection; properties located at 200 & 250 W. Ocean View Dr. In addition, a limited number of volunteers will park in the UPS lot on Ocean Avenue. Letters granting permission to use private properties (Angelina Moura, Bill Patton, Judy Haun, and Felipe Mendoza) for parking are enclosed with this application.

#9. Saturday, September 10, 2016, 7:00 am till 8:00 p.m. (The event officially runs between 11AM-5PM; final set-up 7-11AM; tear-down 5-8PM.)

#11. Hospital Foundation members, volunteers, and licensed security personnel will patrol the Garden grounds to ensure participants' safety and to protect property. No person under 21 years of age will be given or sold alcoholic beverages. Proper ID will be required for admission, and a band will be placed on the wrist of anyone not providing sufficient proof of age, indicating to the vintners (who will be informed in writing of this procedure) that that person should not be served. Posters encouraging moderation will be displayed throughout the Gardens. Copy of letter to Mendocino County Sheriff attached (awaiting response).

#12. We have contacted the Mendocino County Department of Planning & Building Services and CA Fire for permit information.

#13. We have contacted the Mendocino County Environment Health Department and submitted a Community Event Application/Permit.

#14. Sanitation facilities at the Gardens will be supplemented by 24 Porta-Potties (see 15d). Clean-up of the premises and removal of rubbish after the event will be handled Matt Rowland Events, a contracted company who will handle aspects of set up and clean-up and Waste Management Co., respectively (see 15k and l). They will be assisted by the California Conservation Corps (provided they are not needed for fire-fighting elsewhere).

15a. Private Security & Volunteer Security team on duty, Sheriff's Department and CHP office notified about the event/traffic.

15b. Potable in 5 gallon dispensers, 2 ½ gallon jugs on tables throughout venue, supplied by Whispering Pines Water Company.

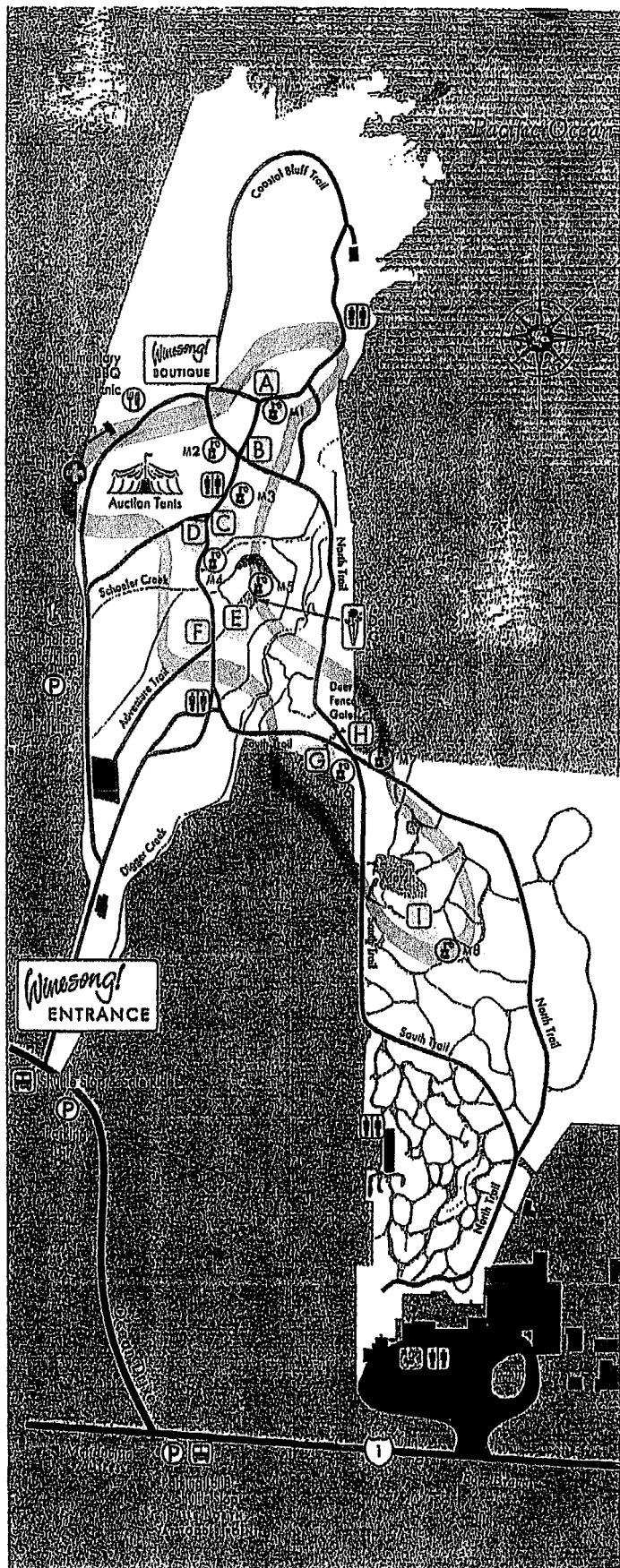
Water is provided from water dispensers (5 gallon) that are placed throughout the gardens by a local water distributor, who will collect his water dispensers after the event.

ARTICLES OF INCORPORATION  
OF  
MENDOCINO COAST HOSPITAL FOUNDATION

I

The name of this corporation is MENDOCINO COAST HOSPITAL  
FOUNDATION.

II

A. This corporation is a nonprofit public benefit corporation and  
is not organized for the private gain of any person. It is organized under  
the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific and primary purposes for which this Corporation is  
formed are charitable, and are to concern themselves with the procure-  
ment and extension of financial aid toward the operation, maintenance  
and modernization of facilities of Mendocino Coast District Hospital, located  
in Fort Bragg, California, in full accord with the purposes of Mendocino  
Coast District Hospital and to the end that the greatest amount of hospital  
service may be extended to the greatest number of persons served by  
Mendocino Coast District Hospital.

III

A. This Corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.



The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. ## Venue Use Agreement

This Venue Use Agreement is entered into on February 12, 2014 by and between MENDOCINO COAST BOTANICAL GARDENS, a California not-for-profit corporation, hereinafter referred to as "MCBG" and the MENDOCINO COAST HOSPITAL FOUNDATION, a California not-for-profit, hereinafter referred to as "MCHF".

This Venue Use Agreement is made with reference to the following facts.

- (1) MCBG is the lessee of certain real property commonly referred to as Mendocino Coast Botanical Gardens, consisting of approximately 47 acres two miles south of Fort Bragg, California.
- (2) MCHF desires to use the facility of MCBG, annually, the Saturdays following Labor Day for the purpose of sponsoring a fundraising event titled 'WINE SONG' on the following dates:  
Saturday, September 6, 2014  
Saturday, September 12, 2015  
Saturday, September 10, 2016

NOW THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

- (1) MCBG hereby agrees to use of the premises described above and MCHF hereby accepts the premises described above for Saturday, September 6, 2014, September 12, 2015 and September 10, 2016.
  - a. MCBG, on the day herein referred to, will close its operations (Admissions, Store, Nursery, Café, tours, classes and access to the coast) to the general public and devote its entire property for the event herein referred to as 'Winesong'.
  - b. MCBG and MCHF are both committed to hosting Winesong in a spirit of cooperation and community benefit.
  - c. MCHF, working in cooperation with MCBG staff, will have access to the facility no later than Tuesday during the week preceding the event to complete the set up of the auction area. On the Friday preceding the event MCHF will have access to the Tasting event areas to set up tables, chairs, flags and canopies. Staging areas will be designated for Thursday equipment drop. Set-up will be predetermined by joint agreement of MCBG and MCHF and will be conducted with as much sensitivity as possible to minimize disturbance to Gardens' visitors on those days. No vehicles will be allowed on narrow paths during visitor hours.
  - d. A Site Coordinator shall be supplied by MCHF to supervise set-up and coordinate activities with MCBG.

- e. At the Winesong event, an auction will be held in the Event Meadow in the southwest corner of the MCBG's facility. MCBG shall prepare the garden area in cooperation with the MCHF's site committee and equipment provider.
  - f. If either MCHF or MCBG determines that major site improvements would benefit the production of Winesong, the parties will negotiate the value and cost of the improvements and MCHF contributions.
  - g. MCHF agrees to work in partnership with MCBG representatives with regard to table location and control of foot traffic. In addition, to enhance communication and coordination concerning the event, a joint task force will be created consisting of up to three members, including the Executive Director and/or Event Coordinator from each organization. This task force will hold its initial meeting in January of each year and will be initiated by MCHF.
  - h. MCHF and MCBG agree to the limitations herein described. The parties agree to cooperate and to protect sensitive plant specimens by cordoning off these areas to foot and vehicle traffic. MCHF agrees to limit the number of tables placed throughout the Gardens to 100, and to limit the total inclusive attendance (including all vendors, restaurant people, volunteers and staff) to 1,800. The density of activity in sensitive plant areas may be limited. MCBG agrees to maintain adequate access for the above stated 100 tables and total inclusive attendance of 1,800. The parties will cooperate in setting the locations for all tables with MCBG having the right of final approval.
  - i. MCHF shall be responsible for cleaning the area after the event as quickly as possible. Where at all feasible, all material should be made of recycled product and that recycled garbage should be placed in containers for recycling. All other debris from the event shall be placed in proper receptacles by the Sunday following the event, and removed by the Monday following the event. Tents and other items shall be removed no later than the following Friday.
2. This is a three year agreement covering the 2014, 2015 and 2016 Winesong events. The use agreement and fee structure will be fixed for the life of this agreement. Unforeseen changes may be negotiated separately.

As a usage fee, MCHF shall pay to MCBG the sum of twenty thousand each year for three years.

- a. MCHF agrees to place a pre-approved full page advertisement in the first half of the auction catalog (at the \$25,000 sponsorship level) that will represent and promote the Gardens and that the Gardens will also be referenced on the event tasting map. The MCHF will give the Gardens the artwork deadline and design parameters at least six weeks in advance.
- b. MCHF agrees to compensate MCBG for the cost of any additional mutually agreed on labor to clean-up the grounds and to cover any damages resulting from this event. MCHF will provide a \$3,000 deposit (consistent with the use of the grounds by every other group with MCBG) by the end of August each year for this purpose.

Representatives of both parties will conduct a thorough post-event inspection of the Gardens on the Monday following the event, and within 14 days following the event mutually determine the total sum for clean-up and/or damage, at which time the remaining deposit will be returned.


- c. MCHF agrees to grant permission to MCBG to use of the Winesong tents and equipment without charge on a) Labor Day Weekend and/or the Sunday following Winesong. MCBG's event schedule must be determined prior to MCHF's production contract negotiations beginning in October of the previous year. MCHF agrees to furnish MCBG a copy of the Winesong Production Contract on or before January 1<sup>st</sup> of the event year. MCBG will be responsible for any additional costs in 'resetting' the Auction area for the purpose of their fundraising concert/events. Additional details will be worked out in a cooperative spirit between the Winesong Event Coordinator or MCHF Executive Director and the MCBG concert/event representative. MCBG agrees to execute a separate agreement for any fundraising concerts/events. MCBG agrees to comply with presenting the Winesong venue as contracted with contracted Production Company. Additionally, MCBG will supply certificates for its liability and other event insurance for any fundraising events and hold harmless MCHF for all non-tent related concerns during the period from its fundraising concert/event set up to breakdown.
  - d. Any shared contractual information is confidential and will not be released beyond the members of the Task Force.
3. The parties agree that during the hours of the event MCHF and MCBG shall co-supervise the event and MCHF shall further supervise parking of vehicles. The Gardens will only be open for Winesong activities from dawn to dusk with the exception of designated work crews that may arrive earlier or stay later. MCHF shall be responsible for providing parking (off-site) and/or shuttle service for the attendees.
- a. MCHF will keep vehicle traffic to a minimum throughout the Gardens. No vehicle traffic will be allowed east of the Narrows Gate. Limited parking will be allowed along the Farmhouse Road in the field immediately west of the Vegetable Garden. Vehicle traffic is limited to walking speed, and under no circumstances shall exceed 5 mph.
  - b. If MCHF needs early access (before 7:30 a.m.) to the Gardens specific requests must be discussed each year at least one week in advance.
4. MCHF agrees to ensure that parking readily remains available for necessary MCBG staff on the day of the Winesong event.
5. MCHF hereby agrees that it will have in force on the event day, set-up and take-down dates, general liability insurance, including property damage and personal injury liability in an amount not less than \$10 million. MCHF shall provide MCBG with written proof of such coverage at least one week before each Winesong event. MCHF shall cause MCBG and the Mendocino

Coast Recreation and Park District to be named as 'additional insured' for this event on the insurance policy covering MCHF.


6. MCBG reserves the right to pursue construction projects which may be in the proximity of the Event Lawn at any time outside the Winesong event timetable of September 1-30 in any year of the term of this agreement. If construction is undertaken, and if the land use format changes as a result of a new building on sites used by Winesong, MCBG will make every effort to provide additional space for lost Winesong venue space. MCBG will notify MCHF of its construction plans no later than 120 days prior to any Winesong event. Upon such notification, MCHF will have the right to terminate this contract within 30 days of notification.
7. In addition thereto, MCHF hereby agrees to hold harmless MCBG from any and all claims, demands, actions and causes of action which may accrue as a result of MCHF's use of the premises on the date/s specified here.
  - a. In addition thereto, MCBG hereby agrees to hold harmless MCHF from any and all claims, demands, actions and causes of action which may accrue as a result of MCBG's negligence during MCHF's use of the premises on the date/s specified herein.
8. MCHF shall not be liable for any venue use fee in the event that inclement weather forces the event to an alternate indoor location, except for actual cost incurred by MCBG in preparation for the event.
9. This Agreement shall inure to the benefit of, and be binding upon, the heirs, administrators and assigns of each of the parties hereto.
10. MCHF shall meet all requirements of the California State Highway Patrol, Mendocino County Sheriff's Office, ABC and the Local Fire Department. MCHF shall obtain all required permits applicable to the event.
11. In the event of default of either party hereto, the non-defaulting party is entitled to Attorneys fees, Court costs and any other incidental costs incurred in the enforcement of the Agreement against the defaulting party.
