

First Modification of Contract BOS 15-074

This First Modification of Contract BOS 15-074 / CDSS Contract No. 15-RCVBL-01264 ("Contract") is between the California Department of Social Services (CDSS) and Mendocino County, through its Health and Human Services Agency (County).

Background

On July 21, 2015, County and CDSS entered into Contract for the provision of Agency adoption services to the County of Mendocino for juvenile matters, under the authority of Welfare and Institutions Code, Section 16130, and in accordance with Title 22 California Code of Regulations, Sections 35127 through 35239. A copy of the Contract is on file with the Office of the Mendocino County Board Clerk, and is incorporated into this First Modification by this reference as though set forth fully herein.

The parties now wish to modify the Contract to extend the term of the contract and add additional funding for Fiscal Year 2016-2017.

Modification

Page 1, the term of the Agreement is modified to read as follows: The term of this Agreement shall be from July 1, 2015 through June 30, 2017.

Page 1, the total amount of the Agreement is modified to read as follows: The compensation payable to CONTRACTOR hereunder shall not exceed Six Hundred Forty One Thousand Six Hundred Eighty Two Dollars (\$641,682) for the term of this Agreement.

Page 6, General Terms and Conditions, Number 19. a. Invoicing is modified to change the third sentence to read as follows: This rate would be claimed up to but not exceeding six hundred forty one thousand six hundred eighty two dollars (\$641,682), the amount of the allocation received by the COUNTY.

Construction

All other terms and conditions of Contract shall remain in full force and effect.

This First Modification is executed in Ukiah, California on this 16 day of August, 2016.
