

RESOLUTION NO. 16-098

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 160044 FOR CONSTRUCTION OF THE MENDOCINO VILLAGE PARKING STRIPING ON LANSING STREET, COUNTY ROAD 500, MILE POST 0.00 TO MILE POST 0.16 AND MAIN STREET, COUNTY ROAD 407E, MILE POST 0.05 TO MILE POST 0.36 (MENDOCINO AREA)

WHEREAS, the Mendocino County Department of Transportation (DOT) desires to construct the Mendocino Village Parking Striping on Lansing Street, County Road (CR) 500, Mile Post (M.P.) 0.00 to M.P. 0.16 and Main Street, CR 407E, M.P. 0.05 to M.P. 0.36; and

WHEREAS, the costs of construction of the Mendocino Village Parking Striping, estimated to be \$100,000, are anticipated to be paid for by the County Road Fund; and

WHEREAS, funding to accommodate construction costs has been budgeted through Budget Unit 3041 (Fiscal Year 2016/17).

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes and directs the Director of Transportation to sign the Notice to Bidders inviting bids for DOT Contract Number (No.) 160044 for construction of the Mendocino Village Parking Striping on Lansing Street, CR 500, M.P. 0.00 to M.P. 0.16 and Main Street, CR 407E, M.P. 0.05 to M.P. 0.36; and
2. Authorizes and directs the Director of Transportation to award DOT Contract No. 160044, upon confirmation of an appropriate low bidder and acceptable contract documents by County Counsel and Risk Management, and report the results to the Board through the applicable Director's Report.






