## **PUBLIC NOTICE**

Public Hearing to Adopt Amendments to Regulation 1, Air Pollution Control Rules of the Mendocino County Air Quality Management District

The Mendocino County Air Quality Management District Board hereby gives notice that it will hold a public hearing to consider the adoption of amendments to Regulation 1, Air Pollution Control Rules of the Mendocino County Air Quality Management District.

Specifically, the District is proposing to amend Regulation 1 Rules 130, Definitions, Rule 200, Permitting Requirements, Rule 220, New Source Review, and Rule 230, Actions on Applications to conform with current federal requirements and allow EPA to approve the District's program as part of the State Implementation Plan (SIP) ensuring that these rules are federally enforceable.

The District is also proposing to withdraw Regulation 1, Rule 221, Federal Permitting for Greenhouse Gas Emissions and Regulation 1, Rule 494 Potential to Emit Limitations from the SIP because these rules do not meet the current criteria for incorporation into the SIP and are federally unenforceable. The Rules will remain in effect as locally enforceable rules.

The hearing will be held as part of a regularly scheduled meeting of the Mendocino County Board of Supervisors/Air Quality Management District Board, on Tuesday, September 20, 2016, at 1:30 pm, in the Board of Supervisors' Chambers, 501 Low Gap Road, Ukiah, California.

The proposed regulation is categorically exempt from review under the California Environmental Quality Act (CEQA), as provided in the California Code of Regulations, Section 15308. Copies of the proposed regulation, all petitions, applications and other documents pertaining to the above matter are available for viewing by the public at the office of the Air Quality Management District, 306 E. Gobbi St., Ukiah, California, 95482. All interested parties may view such records and attend the hearing.
