

RESOLUTION NO. 16-115

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE CALIFORNIA COASTAL COMMISSION TO PROCESS A CONSOLIDATED COASTAL DEVELOPMENT PERMIT REQUEST FROM THE CALIFORNIA DEPARTMENT OF TRANSPORTATION TO CONDUCT GEOTECHNICAL DRILLING AT THE ALBION RIVER BRIDGE ON STATE ROUTE 1

WHEREAS, Section 30601.3 of the Public Resources Code allows for a consolidated permitting process for projects for which the Coastal Development Permit (CDP) authority is shared by a local government and the California Coastal Commission (Commission), and

WHEREAS, in order for the Commission to process and act upon a consolidated CDP application, Section 30601.3 of the Public Resources Code requires that the applicant, the local government and the Commission consent to the consolidation, provided that public participation is not substantially impaired by the consolidation, and

WHEREAS, the geotechnical drilling at the Albion River Bridge of State Route 1 project is under the coastal development permit authority of both Mendocino County and the Commission and would otherwise require a coastal development permit from both Mendocino County and from the Commission for the portions of the geotechnical drilling located within each jurisdiction, and

WHEREAS, public participation will not be substantially impaired as the Commission will hold a public hearing on the project, allowing interested parties to submit timely comments to the Commission and/or attend said hearing, and which consolidated permit process will allow for this project to be evaluated in its entirety.


NOW, THEREFORE, BE IT RESOLVED, that the Mendocino County Board of Supervisors authorizes the California Coastal Commission to accept and process a consolidated Coastal Development Permit request from the California Department of Transportation to conduct geotechnical drilling at the Albion River Bridge of State Route 1.






