

RESOLUTION NO. 16-116

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS TO AUTHORIZE THE SHERIFF TO SIGN FUTURE BOARD OF STATE AND COMMUNITY CORRECTIONS BYRNE JUSTICE ASSISTANCE GRANT (JAG) RENEWAL APPLICATIONS INCLUDING ANY AND ALL DOCUMENTS, AND/OR SUBSEQUENT AMENDMENTS WITH THE CHIEF EXECUTIVE OFFICER OR DESIGNEE REVIEW AND PRIOR APPROVAL

WHEREAS, the Board of Supervisors approved application submission for the State and Community Corrections Byrne Justice Assistance Grant (JAG) grant on October 20, 2015, Board Action Number 4(f) and Resolution Number 15-157; and

WHEREAS, the Sheriff's Office will notify the CEO, County Counsel and Risk Management for review of any and all renewals, documents and/or subsequent amendments associated with the State and Community Corrections Byrne Justice Assistance Grant (JAG) grant as per County Policy 25; and

WHEREAS, the State and Community Corrections Byrne Justice Assistance Grant (JAG) grant will benefit the County and its residents with recidivism efforts particularly related to those experiencing behavioral health issues ; and

WHEREAS, failing to reapply for State and Community Corrections Byrne Justice Assistance Grant (JAG) grant would not be in the best interest of the County.


NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors authorize the Mendocino County Sheriff to sign future renewal applications including any and all documents, and/or subsequent amendments associated with the State and Community Corrections Byrne Justice Assistance Grant (JAG) grant, with the Chief Executive Officer or Designee review and prior approval, as per County Policy 25 "Grant Applications and Contracts" section "Existing Grant Renewals and Amendments".

The foregoing Resolution introduced by Supervisor McCowen, seconded by Supervisor Brown, and carried this 13th day of September, 2016, by the following vote:






