RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING PARCEL MAP FOR MINOR SUBDIVISION NUMBER 02-2008 (FREY TOMKI PROPERTIES, LLC) AND ACCEPTING ON BEHALF OF THE PUBLIC ITEM (A) OF THE OWNER'S STATEMENT FOR THE PURPOSES SPECIFIED THEREON, LOCATED AT 14000 TOMKI ROAD; APN'S 107-200-18, 107-180-05, 107-190-15 AND 107-265-19 (REDWOOD VALLEY AREA)

WHEREAS, on August 19<sup>th</sup> 2010 the Mendocino County Planning Commission conditionally approved the tentative map for Minor Subdivision (MS) Number 02-2008; and

WHEREAS, all conditions of approval have been complied with or otherwise provided for, including offers of dedication and preparation of the Parcel Map; and

WHEREAS, all statements on said map have been executed by their respective assignees; and

WHEREAS, the Mendocino County Redemption Officer has determined that there are no liens against the real property defined by this subdivision or any part thereof for unpaid State, County, Municipal or Local Taxes, or special assessments collected as taxes, except taxes of special assessments not yet payable; and

WHEREAS, the Mendocino County Assessor has estimated the amount of taxes and assessments, which are a lien against the real property, contained within the Subdivision for taxes or special assessments not yet payable, to be fourteen thousand, four hundred eighteen dollars and zero cents (\$14,418.00), said amount having been deposited with the County Treasurer as surety in accordance with applicable provisions of the State Subdivision Map Act.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

- 1. Approves for filing the Parcel Map for MS 02-2008.
- 2. Accepts on behalf of the public Item (A) of the Owner's Statement on the Parcel Map for the purposes specified thereon.
- 3. Authorizes and directs the Clerk of the Board to sign said Parcel Map authorizing its filing, accepting said dedication in Item (A) above and deliver said Parcel Map to the Recorder for further processing and recording.
