## BOARD OF SUPERVISORS (BOS) AGREEMENT NO. 12-006/DEPARTMENT OF TRANSPORTATION (DOT) AGREEMENT NO. 110103

This Amendment No. 6 to BOS Agreement No. 12-006/DOT Agreement No. 110103 is entered into this day of 2010, 2016, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Drake Haglan and Associates; 11060 White Rock Road, Suite 200; Rancho Cordova, CA, hereinafter referred to as "CONSULTANT".

WHEREAS, BOS Agreement No. 12-006/DOT Agreement No. 110103 was entered into under Resolution 12-016 on January 10, 2012, modified by Amendment No. 1 dated June 29, 2012; Amendment No. 2 (Historic Resources Evaluation Report) dated October 24, 2012; Amendment No. 3 (Extended Phase 1 Investigation) on September 27, 2013; Amendment No. 4 (time extension) on October 28, 2014; and Amendment 5 (time extension) on December 15, 2015; and

WHEREAS, upon execution of this document by the County of Mendocino and the Consultant, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, additional design work is required to accommodate the property owners from whom additional right-of-way is necessary; and

WHEREAS, additional coordination with the permitting agencies is required to obtain the necessary permits; and

WHEREAS, it is the desire of the CONSULTANT and the COUNTY to complete said design changes and additional permit coordination for an additional amount of \$20,770; and

WHEREAS, it is mutually agreed between COUNTY and CONSULATANT that payments to CONSULTANT including the total amount of salaries and expenses included in the original agreement and Amendment Nos. 1 to 6 shall be increased to a not-to-exceed amount of \$576,470.

NOW, THEREFORE, we agree as follows:

- 1. CONSULTANT shall provide additional design changes and permit coordination.
- 2. The total-not-to-exceed amount of BOS Agreement No. 12-006/DOT Agreement No. 110103 is increased by \$20,770 to five hundred seventy-six thousand, four hundred seventy dollars (\$576,470) for the term of this agreement.

All other terms and conditions of <u>BOS Agreement No. 12-006/DOT Agreement No.</u> 110103 shall remain in full force and effect.
