9-22/16 SUMMARY OF PROPOSED ORDINANCE MENDOCINO COUNTY ORDINANCE 7.04

THE PRIMARY PURPOSE OF THE PROPOSED AMENDMENTS TO THIS ORDINANCE ARE TO PRO-CLARITY VIDE GREATER ROLES AND RESPONSIBILITIES OF THIS COUNTY AND OTHER PUB-LIC AGENCIES, CORPORATIONS, ORGANIZATIONS, AND AFFECTED PRIVATE PERSONS RESPONSIBLE FOR PREPARING FOR AND RE-SPONDING TO EMERGENCIES IN MENDOCINO COUNTY, AND TO BRING THE ORDINANCE INTO COMPLIANCE WITH CURRENT COMPLIANCE WITH CURRENT BEST PRACTICES FOR EMERGEN-MANAGEMENT. SECTION 7.04.110 IS ALSO CHANGED TO REFLECT A CHANGE IN STATE LAW THAT THE BOARD OF SU-PERVISORS MUST REVIEW THE NEED FOR CONTINUING THE LO-NEED FOR CONTINUING THE LO-CAL EMERGENCY AT LEAST ONCE EVERY 30 DAYS INSTEAD OF 14 OR 21 DAYS. THE AMENDMENTS UPDATE THE ROLES OF THE DI-RECTOR OF EMERGENCY SERV-ICES, ASSISTANT DIRECTOR OF EMERGENCY SERVICES AND EMERGENCY SERVICES COORDI-NATOR TO REFLECT CURRENT AND REST PRACTICES, ADDITION-AND BEST PRACTICES. ADDITION-ALLY, THE CURRENT VERSION OF THE ORDINANCE HAS LANGUAGE REGARDING THE E MENDOCINO EMERGENCY SERVICES AGENCY (MESA) AGREEMENT THAT EX-ISTED BETWEEN THE CITIES AND COUNTY OF MENDOCINO BUT IS NO LONGER IN EXISTENCE. THE THE MESA SECTIONS HAVE BEEN RE-MOVED TO ENSURE THE ORDI-MOVED TO ENSURE THE ORDI-NANCE REFLECTS THE CURRENT OES ORGANIZATIONAL STRUC-TURE. FINALLY, NAMES OF VARI-OUS SYSTEMS AND POSITIONS HAVE BEEN UPDATED.

THE PROPOSED ORDINANCE IS SCHEDULED FOR ADOPTION ON OCTOBER 4, 2016.
