**Points of Discussion:**

- The goal of CalFire is to maintain timberlands;
- Definition of the term "timberland";
- Any timberland conversions must be permitted before the conversion commences;
- Setback requirements for various types of parcels;
- Number of permits an individual may possess;
- Power usage required for cultivation of cannabis and types of energy used for cultivation;
- Plant count versus square footage;
- Issues with the permitting process experienced by the California Department of Fish and Wildlife in Humboldt County, specifically: illegal activity, volume of permit applications, enforcement, environmental damage, water quality, and watershed management;
- Issues raised by the North Coast Regional Water Quality Board;
- Impact of a potential ordinance on small family farms.

- To direct staff to discuss issues outlined by CalFire and the North Coast Regional Water Quality Control Board; address issues related to power usage and generators, square footage, Williamson Act, Marijuana Innovation Zone, cannabis facilities ordinance; research a potential amnesty program for unpermitted structures
