AMENDMENT TO COUNTY OF MENDOCINO STANDARD SERVICES AGREEMENT NO. PA# 16-99

This Amendment to Agreement No. PA# <u>16-99</u> is entered into this ______ day of _____, 2016, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>LACO Associates</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA# 16-99 was entered into on May 1, 2016; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. PA# <u>16-99</u>, from <u>December 31</u>, <u>2016</u> to <u>June 30</u>, <u>2017</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the contract amount set out in the original Agreement No. PA# <u>16-99</u>, from <u>not to exceed fifty thousand dollars (\$50,000)</u> to <u>not to exceed seventy-seven thousand dollars (\$77,000)</u>; and

WHEREAS, LACO Associates provides the County with professional services specific to the development of a Medical Cannabis Cultivation Regulation Initial Study pursuant to the California Environmental Quality Act; and

WHEREAS, increasing the contract amount and extending the termination date will increase support services for the Medical Cannabis Cultivation Regulation Initial Study to include assistance with public hearings, strategy sessions and special meetings.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original Agreement No. PA# <u>16-99</u> will be extended from <u>December 31, 2016</u> to <u>June 30, 2017</u>.
- 2. Increase the contract amount set out in the original Agreement No. PA# <u>16-99</u>, from not to exceed fifty thousand dollars (\$50,000) to not to exceed seventy-seven thousand dollars (\$77,000);
- 3. Exhibit A, Definition of Services, is amended to include the services listed in the Exhibit A Addendum attached to this Amendment.

All other terms and conditions of Agreement No. PA# <u>16-99</u> shall remain in full force and effect.

EXHIBIT A – Addendum

DEFINITION OF SERVICES

CONTRACTOR shall provide the following services:

Task 1: Public Hearing, Strategy Sessions, and Special Meetings

- LACO will support the County during the public review process of the Initial Study by attending strategy sessions with County staff, preparing for and attending public hearings, and participating in special meetings as requested by Client.
- LACO staff will be available for up to 40 hours of strategy sessions and public hearing preparation with the County.
- LACO will attend two Planning Commission hearings and three Board of Supervisor Hearings (may include 1 closed session meeting) regarding the Initial Study. This assumes up to five hours at each hearing.
- LACO will be available for up to 20 hours of special meetings. This time allowance includes preparation and attendance by phone or in person at such meetings. These may include meetings with individual County Supervisors, stakeholders, or others.

Task 2: Special Assignments

 LACO will be available to perform on special assignments such as preparing memorandums on status or particular areas of interest suitable for delivery to the Planning Commission, Board of Supervisors, or other party as directed by the County. This task includes an allowance of up to 20 hours for these efforts.

SPECIAL CONDITIONS, ASSUMPTIONS, AND SERVICES NOT PROVIDED

- Tasks not specifically identified in the Scope of Services above are not included.
- Task budgets are estimates of required effort; to meet project objectives, LACO may adjust the budget allocations for tasks, but may not invoice in excess of the total estimated cost without written approval from the County.
- All special conditions, assumptions, and services included in the Agreement No. PA# 16-99, apply unless modified with this contract amendment.
