AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NOS. BOS 14-037 & BOS 14-037 A1

This Amendment No. 2 to BOS Agreement Nos. <u>BOS 14-037 & BOS 14-03 A1</u> is entered into this <u>4</u> day of <u>f(pri)</u>, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>West Company</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. <u>BOS 14-037</u> in the amount of \$277,500 was entered into on <u>June 17, 2014</u>; and

WHEREAS, BOS Agreement No. <u>BOS 14-037A1</u> was entered into on June 7, 2016; to increase the "Not to Exceed" value set in the original agreement from \$277,500 to \$340,500;

WHEREAS, the Board of Supervisors on November 3, 2015 approved **Resolution No.15-162** to allocate an additional \$70,000 of Community Development Block Grant (CDBG) funding to West Company to continue providing Microenterprise Business Technical Assistance Services, of which amount only \$63,000 was allocated by BOS Agreement No. <u>BOS 14-037A1</u>, leaving an available balance of \$7,000; and

WHEREAS, the Board of Supervisors on June 6, 2016 approved **Resolution No.16-075** to allocate an additional **\$76,320** of Community Development Block Grant (CDBG) funding to West Company to continue providing Microenterprise Business Technical Assistance Services; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the Agreement "Not to Exceed" value set out in the original BOS Agreement Nos.<u>BOS14-037 & BOS14-037A1</u>, from \$340,500 to \$423,820; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and West Company, this document will become part of the aforementioned contracts and shall be incorporated therein.

NOW, THEREFORE, we agree as follows:

1. The "Not to Exceed" value set out in the original BOS Agreement No. <u>BOS 14-037 & BOS 14-037A1</u> will be increased from **\$340,500** to **\$423,820**.

All other terms and conditions of BOS Agreement Nos. <u>BOS 14-037 & BOS 14-037A1</u> shall remain in full force and effect.
