

**AMENDMENT NO. 7 TO THE COUNTY OF MENDOCINO
AGREEMENT WITH DRAKE HAGLAN & ASSOCIATES
FOR ENGINEERING CONSULTANT SERVICES FOR THE
FORSYTHE CREEK BRIDGE REPLACEMENT ON REEVES CANYON ROAD**

**BOARD OF SUPERVISORS (BOS) AGREEMENT NO. 12-006/DEPARTMENT OF
TRANSPORTATION (DOT) AGREEMENT NO. 110103**

This Amendment No. 7 to BOS Agreement No. 12-006/DOT Agreement No. 110103 is entered into this 6th day of June, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Drake Haglan and Associates; 11060 White Rock Road, Suite 200; Rancho Cordova, CA, hereinafter referred to as "CONSULTANT".

WHEREAS, BOS Agreement No. 12-006/DOT Agreement No. 110103 was entered into under Resolution 12-016 on January 10, 2012, modified by Amendment No. 1 dated June 29, 2012; Amendment No. 2 (Historic Resources Evaluation Report) dated October 24, 2012; Amendment No. 3 (Extended Phase 1 Investigation) on September 27, 2013; Amendment No. 4 (time extension) on October 28, 2014; Amendment 5 (time extension) on December 15, 2015; and Amendment 6 (additional design expenses); and

WHEREAS, upon execution of this document by the County of Mendocino and the Consultant, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, construction design support services are needed during the construction phase of the project, including submittal reviews and observation services; and

WHEREAS, this work is ordinarily performed by the designing engineers and is part of the original scope of work; and

WHEREAS, it is the desire of the COUNTY for the CONSULTANT to provide said services for an additional amount of \$57,561; and

WHEREAS, it is mutually agreed between COUNTY and CONSULTANT that payments to CONSULTANT including the total amount of salaries and expenses included in the original agreement and Amendment Nos. 1 to 7 shall be increased to a not-to-exceed amount of \$634,031.

NOW, THEREFORE, we agree as follows:

1. CONSULTANT shall provide construction design support services for the replacement of the Forsythe Creek Bridge on Reeves Canyon Road.
2. The total-not-to-exceed amount of BOS Agreement No. 12-006/DOT Agreement No. 110103 is increased by \$57,561 to six hundred thirty-four thousand, thirty-one dollars (\$634,031) for the term of this agreement.
3. Extend the expiration of BOS Agreement No. 12-006/DOT Agreement No. 110103 to December 31, 2018.

All other terms and conditions of BOS Agreement No. 12-006/DOT Agreement No. 110103 shall remain in full force and effect.
