## **Museum Update**

The Mendocino County Museum in Willits was closed on June 8th for a short period of time due to concerns over mold. Some areas of the Museum were reopened to the public on Saturday, June 11, 2016. The Museum lobby, store, Main Gallery and Engine House are accessible to the public during the Museum's normal business hours.

Extensive testing was conducted throughout the Museum and determined which areas are completely safe to the public. The areas mentioned above have been cleared for normal use by certified environmental scientists. Some areas of the Museum will remain off limits until remediation work can be completed. Initial remediation work will begin in the museum classrooms on Wednesday, June 22, 2016, and will continue over the next several weeks. The Executive Office will continue to provide updates with any changes to public access.

## **Mendocino County Job Fair**

The upcoming County Job Fair is a great first step in the hiring process and will provide attendees with the opportunity to apply for current job openings explore the diverse selection of careers within the County of Mendocino and interact with County representatives from all departments and offices. The fair will include breakout sessions highlighting individual county departments/offices, hands on assistance with the web-based application process and opportunities to apply online for current openings. Attendees can also take advantage of onsite community education information, training partners, information on becoming an intern or being a member of one of the boards and commissions. You will be provided with information concerning the next steps of the hiring process when you attend one of the various workshops available. #### California Public Utilities Commission

On July 15, 2016, the County will be hosting a California Public Utilities Commission (CPUC) Public Participating Hearing (PPH) regarding the Call Completion Proceeding. This hearing will be held in the Board of Supervisors Chambers at 501 Low Gap Road, Ukiah. More information will be provided prior to the meeting time. The PPH will focus on call completion issues, including outages that compromise access to 911 services, and also LifeLine's availability, both wireline and wireless, in our area.

## **Senate Bill 272 Implementation**

Counties face a July 1 deadline to comply with California's newest Public Records Act requirement: a catalog of the agency's record keeping systems. Put in place by SB 272 (Hertzberg, 2015), the development of this catalog will require counties and other public agencies to take an inventory of the "enterprise systems" maintained by every department, along with information such as what data is kept there, how often the data is updated, and who the system's vendor is. Currently, a team led by the Information Services Division of the Executive Office is working on completing this requirement. The information will be posted on the County's website by July 1, 2016.

## **Legislative Update**

The Legislature sent the 2016-17 budget package totaling \$122.5 billion in General Fund revenue to the Governor in two phases, working quickly Wednesday afternoon to pass the main budget bill and meet the June 15 constitutional deadline. The Governor's January Budget proposal to augment the Proposition 2 "Rainy Day Fund" by an additional \$2 billion dollars was approved and brings total reserves to \$8.5 billion.

In addition, the Legislature approved a \$2 billion spending plan to renovate state offices including the Capitol Annex and address deferred maintenance. Ongoing commitments that the Legislature sought includes funding child care and pre-school rate increases that will grow to over \$500 million annually.

## **Animal Care Services Update**

The Ukiah Animal Shelter has been very busy with various building improvements, including: the remodel of the pet intake area, installation of new kennels in the police hold area, installation of cat portals, and new evaporative coolers in the kennel area. While the projects have been somewhat disruptive to the normal flow of the shelter, things are now in the process of being put back together. The improvement plan presented to the Board on May 3, 2016, is being implemented and a progress update on the projects is detailed in the attached matrix. All short term items are on track for completion by the end of June. Progress updates will be provided monthly with each additional CEO Report.

"Kitten season" is in full swing and we currently have 144 cats and kittens under our care. We are showcasing kittens in the lobby area and are getting numerous adoption applications. We are also running adoption "specials" on cats and dogs to shorten length of stays and relieve our "full house". In addition to a full house in the kennels and cattery, some staffing turnover and has left staffing stretched. Interviews for extra help kennel support will be this week. Shelter staff and volunteers are all putting in extra effort to make sure the animals are well cared for during this busy time.

Staff and volunteers have participated at several off-site adoption events, bringing our animals out in front of the public. Adoptions on both dogs and cats are up as are transfers to other rescue organizations. Staff and volunteers are working diligently to get animals out of the shelter as quickly as possible.

## **Water Agency News**

On Tuesday June 14, 2016, the Water Agency hosted its first Ukiah Valley Basin SGMA Implementation Public Workshop with Cal State Sacramento's Center for Collaborative Management's facilitation team. Water providers, government entities and interested parties throughout the Ukiah Valley participated in the workshop. The meeting consisted of an overview of SGMA, the results of the facilitation team's initial stakeholder assessment. information on Ukiah area groundwater studies and discussion on Groundwater Sustainability Agency formation. The next workshop will be in mid-July. The Water Agency will update the Board when a date has been set.
