AMENDMENT TO COUNTY OF MENDOCINO STANDARD SERVICES AGREEMENT NO. PR-P16-001

This Amendment to Agreement No. <u>PR-P16-001</u> is entered into this <u>J</u> day of August, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>FORD STREET PROJECT</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PR-P16-001 was entered into on July 2, 2015; and

WHEREAS, Agreement No. PR-P16-001 was amended on May 25, 2016; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to extend the termination date set out in the original Agreement No. <u>PR-P16-001</u>, from <u>June 30</u>, 2016 to June 30, 2018; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original Agreement No. <u>PR-P16-001</u> from <u>Twenty Thousand Dollars (\$20,000)</u> to <u>Sixty Thousand Dollars (\$60,000)</u>.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original Agreement No. <u>PR-P16-001</u> will be extended from June 30, 2016 to <u>June 30, 2018</u>.
- 2. The total contract amount set out in the original Agreement No. <u>PR-P16-001</u> will be increased from <u>Twenty Thousand Dollars</u> (\$20,000) to <u>Sixty Thousand Dollars</u> (\$60,000).

All other terms and conditions of Agreement No. <u>PR-P16-001</u> shall remain in full force and effect.
