WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>PR-B16-044</u>, from <u>June 30, 2017</u> to <u>June 30, 2018</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original Agreement No. <u>PR-B16-044</u> from <u>Three Hundred and Sixty Thousand Dollars (\$360,000.00)</u> to <u>Seven Hundred and Twenty Thousand Dollars (\$720,000.00)</u>.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>PR-B16-044</u> will be extended from <u>June 30, 2017</u> to <u>June 30, 2018</u>.
- 2. The total contract amount set out in the original BOS Agreement No. <u>PR-B16-044</u> will be increased from <u>Three Hundred and Sixty Thousand Dollars (\$360,000.00)</u> to <u>Seven Hundred and Twenty Thousand Dollars (\$720,000.00)</u>.

All other terms and conditions of BOS Agreement No. <u>PR-B16-044</u> shall remain in full force and effect.
