**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. PR-B16-044**

This Amendment to BOS Agreement No. PR-B16-044 is entered into this 15th day of August, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and B.I. Incorporated d/b/a/ BI Correctional Services Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. PR-B16-044 was entered into on June 21, 2016; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. PR-B16-044, from June 30, 2017 to June 30, 2018; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original Agreement No. PR-B16-044 from Three Hundred and Sixty Thousand Dollars (\$360,000.00) to Seven Hundred and Twenty Thousand Dollars (\$720,000.00).

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. PR-B16-044 will be extended from June 30, 2017 to June 30, 2018.
2. The total contract amount set out in the original BOS Agreement No. PR-B16-044 will be increased from Three Hundred and Sixty Thousand Dollars (\$360,000.00) to Seven Hundred and Twenty Thousand Dollars (\$720,000.00).

All other terms and conditions of BOS Agreement No. PR-B16-044 shall remain in full force and effect.
