GENERAL CONSENSUS OF THE BOARD that staff shall find an interim mechanism for individuals in the application process that would state the County finds them in compliance, therefore making them eligible to apply for State permits.

GENERAL CONSENSUS OF THE BOARD that any existing structure not in compliance with building code is eligible for amnesty and would not prohibit issuance of a permit, subject to a completed application. Individuals will have one year to fix violation so long as they are diligently pursuing remedies to address the code violation issues.

GENERAL CONSENSUS OF THE BOARD that the application deadline shall be extended to June 30, 2018.

GENERAL CONSENSUS OF THE BOARD that staff shall develop an overlay or exemption for areas who wish to opt out of cannabis cultivation.

BOARD OF SUPERVISORS - ACTION MINUTES - JULY 18, 2017

GENERAL CONSENSUS OF THE BOARD that individuals removing trees for the purpose of cannabis cultivation or removed without permission from CalFire, prior to May 4th, 2017, will not be eligible for a permit; and directing County Counsel to research the earliest operative date that is reasonable to impose this permit denial criteria.

GENERAL CONSENSUS OF THE BOARD that staff may combine cultivation types into one permit, not to exceed 10,000 square feet per parcel of mixed license types.

GENERAL CONSENSUS OF THE BOARD that exemption stacking is prohibited.

GENERAL CONSENSUS OF THE BOARD that staff shall review the issue of road easements that allow access to cannabis cultivation sites, including potential limitation regarding use of neighbor's roads and bridges.

BY ORDER OF THE CHAIR staff shall investigate and provide information regarding transferability of permits from coastal to inland zone.

GENERAL CONSENSUS OF THE BOARD for staff to return to the Board with details regarding enforcement concerns and processes.

GENERAL CONSENSUS OF THE BOARD for staff to research the State requirements in respect to prohibition regarding felonies, wherein "felonies" only refers to violent or serious crimes; and modify our requirements to conform accordingly.

GENERAL CONSENSUS OF THE BOARD for stall to include language that allows extinguish and transfer for properties not subject to the sunset provision.

GENERAL CONSENSUS OF THE BOARD that staff shall provide recommendations to the Board regarding provisional permit status.

GENERAL CONSENSUS OF THE BOARD that staff shall provide additional information regarding transferability of permits from coastal to inland zone.

GENERAL CONSENSUS OF THE BOARD to modify Ordinance allowing applicants to submit copies of Board of Equalization sales (wholesale) reports or receipts of transactions with legitimate patient dispensing collectives, processors or manufacturers after transactions have occurred, rather than requiring proof of an upfront agreement.

GENERAL CONSENSUS OF THE BOARD that staff shall provide language clarifying compliance for proof of prior cultivation, as follows: If applicant was out of compliance with Ordinance in 2010 when setbacks requirements were adopted, they have no valid entitlement to seek to transfer. If they could not possibly comply, then they never could have received a permit, and therefore have nothing to transfer. If they could comply going forward (even if not in compliance in the past) then they would be eligible to apply and move forward on existing cultivation site. However, they still must be able to comply with setbacks on their current parcel; and must have been cultivating prior to January 1, 2016, with exceptions to 2016 permit program, limited to those in that program.
