RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS REQUESTING PERMISSION FROM CALIFORNIA HIGHWAY PATROL (CHP) FOR THE "ROUND VALLEY HIGH SCHOOL FOOTBALL HOMECOMING PARADE" TO BE HELD IN COVELO, CALIFORNIA, ON FRIDAY, OCTOBER 20, 2017, ON STATE ROUTE 162.

WHEREAS, the Round Valley High School is planning their Football Homecoming Parade on Friday, October 20, 2017, and are requesting permission to hold a parade on that day at 4:00 p.m. on State Route 162.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby requests the California Department of Transportation (CalTrans) to grant their permission, pursuant to the California Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Highway Right of way, for the Round Valley High School to hold a parade on State Route 162 from Eberle Street to Howard Street, on October 20, 2017, road closure to commence at 4:00 p.m. to 5:00 p.m; said parade route being in the town of Covelo.

BE FURTHER RESOLVED that the Clerk of the Board of Supervisors is directed to forward copies of this Resolution to the Caltrans District Permit Coordinator (Eureka), the California Highway Patrol, and the Round Valley High School Principal.
