Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall present an agenda item for the August 15, 2017, Regular Meeting to revise the Board of Supervisors 2017 Master Meeting Calendar, adding Regular Meetings on August 22, 2017, and August 29, 2017.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall work with CalFire to define “timberland” and determine appropriateness of the term “timberland” versus “resourceland” in respect to conversion issues; and to add clarification to the proposed amendment to 10.A.17.040 stating that tree removal for the purpose of defensible space, for removal of dead, dying or diseased trees, or at the direction of CalFire shall not result in the denial of a permit.

Board Directive: GENERAL CONSENSUS OF THE BOARD that the Board of Supervisors is supportive in moving toward the ability to allow coastal zone permitting; and that staff shall continue to explore options to allow for Coastal Zone cultivation.

Board Directive: GENERAL CONSENSUS OF THE BOARD that County Counsel shall investigate options for providing an interim permit or certificate of good standing for cultivators located in the Coastal Zone to use in obtaining a State permit.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall present an item for a revised fee permit schedule to the Board of Supervisors in September or October – or as soon thereafter as feasible.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall propose modified language which would allow for expansion of previously existing cultivation sites in future years.

Board Directive: GENERAL CONSENSUS OF THE BOARD that new County Cannabis Cultivation Permit Applications will commence in Planning and Building Services for the purpose of obtaining a basic zoning clearance prior to proceeding to the Department of Agriculture.

Board Directive: GENERAL CONSENSUS OF THE BOARD that should third party inspectors be removed from the Ordinance, the County will refund any paid third party fees. If the Board should reduce the fee schedule, those that paid full fee for both permits would be eligible for a refund to the level of the newly reduced fee.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall incorporate language into the Ordinance eliminating detailed lighting requirements for cultivation including nurseries, provided there is no weakening of the protection of the night sky, and prohibition of light that would offend neighbors.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall investigate transferability options for permits, based on CEQA exemptions.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall make the consideration of the conditional permit process a priority, which shall include the potential for creating a document for somebody who is in the process in conformance with the Trailer Bill, in response to requests from the State.

Board Directive: GENERAL CONSENSUS OF THE BOARD for staff to research a reasonable way to address flexibility in Ordinance setback language.

Board Directive: GENERAL CONSENSUS OF THE BOARD for staff to prepare a revision to the Ordinance eliminating the role of third party inspectors.

Board Directive: GENERAL CONSENSUS OF THE BOARD that the Board of Supervisors supports revising County Code to allow for the use of portable toilets, providing they are properly serviced.

Board Directive: GENERAL CONSENSUS OF THE BOARD that staff shall return in the afternoon session with revisions to the proposed amendment to County Code Section 18.12.010 as outlined in item 1 of the memorandum presented by Mr. Oliphant as follows: “The structure is designed and constructed for use in housing livestock, poultry, hay, grain, and/or drying of plant material and is located on a parcel of land that is currently zoned or primarily used for agriculture.”
