RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS PURSUANT TO CALTRANS/CALIFORNIA HIGHWAY PATROL'S JOINT POLICY GUIDELINES FOR SPECIAL EVENTS ON STATE CONVENTIONAL HIGHWAYS IN ORDER TO OBTAIN A PERMIT FROM CALTRANS FOR THE ROUND VALLEY HIGH SCHOOL HOMECOMING PARADE IN COVELO, CALIFORNIA ON OCTOBER 20, 2017

WHEREAS, the Round Valley High School wishes to hold a parade in connection with the football homecoming game celebration; and

WHEREAS, said parade will be held on October 20, 2017 between 4:00 P.M. and 5:00 P.M. Commencing on Eberle Street, the parade will proceed east on Eberle Street until it meets Highway 162 (also known as Covelo Road), where it will turn north and continue on Highway 162 through the town of Covelo, then turn west and proceed on Howard Street, ending in the Round Valley High School parking lot located on the corner of Howard Street and High School Street.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby support the Round Valley High School Homecoming Parade and seeks the support and cooperation of any involved agencies.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors does hereby state that any liabilities and responsibilities shall rest with the parade sponsors.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors requests the State Department of Transportation to give their permission pursuant to the Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Rights of Way, for the Round Valley High School Homecoming Parade to be held in Covelo, California, on Eberle Street, Highway 162, and Howard Street on October 20, 2017.



The foregoing Resolution introduced by Supervisor Croskey, seconded by Supervisor Brown, and carried this 3rd day of October, 2017, by the following vote:






