



RELINQUISHMENT OF HIGHWAY RIGHT OF WAY IN THE COUNTY OF MENDOCINO, ROAD 01-MEN-101-17.2-22.2 REQUEST NO. 754

WHEREAS, the California Highway Commission on April 18, 1956, adopted a resolution declaring a certain section of State highway, road Ol-Men-101 (former I-Men-1-By, to be a freeway; and

WHEREAS, by freeway agreement dated October 18, 1962, between the County of Mendocino and the State of California, the County agreed to accept control and maintenance of frontage roads, and to accept title thereto upon relinquishment thereof to said County by the State of California; and

WHEREAS, the State of California has acquired right of way for and has constructed said roads in the County of Mendocino between 6 miles north of Hopland and Norgard Lane near Ukiah, road 01-Men-101 (former I-Men-1-B), in connection with said freeway; and

WHEREAS, this Commission has found and determined, and does hereby find and determine, that it is desirable and in the public interest that said roads be relinquished to the County of Mendocino for use as county highways;
