WHEREAS, it is the desire of MENDOCINO and LAKE to extend the termination date set out in the BOS Agreement No. <u>17-048-A1</u>, from <u>October 31</u>, <u>2017</u> to <u>December 31</u>, <u>2017</u>; and.

WHEREAS, upon execution of this Amendment by the Chair of the Mendocino County Board of Supervisors and the Chair of the Lake County Board of Supervisors, this document will become part of the aforementioned Memorandum of Understanding and shall be incorporated therein.

NOW, THEREFORE, MENDOCINO and LAKE agree as follows:

- 1. The termination date set out in the BOS Agreement No. <u>17-048-A1</u> will be extended from <u>October 31, 2017</u> to <u>December 31, 2017</u>.
- 2. This Amendment may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all counterparts together shall constitute a single agreement.

All other terms and conditions of BOS Agreement No. <u>17-048</u> shall remain in full force and effect.
