AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 16-083

This Amendment to BOS Agreement No. 16-083 is entered into this day of 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and B.I. Incorporated d/b/a BI Correctional Services Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-083 was entered into on September 20, 2016; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>16-083</u>, from <u>September 30, 2017</u> to <u>September 30, 2018</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original BOS Agreement No. <u>16-083</u> from <u>Seventy Thousand Dollars (\$70,000.00)</u> to <u>One Hundred Forty Thousand Dollars (\$140,000.00)</u>.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>16-083</u> will be extended from <u>September 30, 2017</u> to <u>September 30, 2018</u>.
- 2. The total contract amount set out in the original BOS Agreement No. <u>16-083</u> will be increased from <u>Seventy Thousand Dollars (\$70,000.00)</u> to <u>One Hundred Forty Thousand Dollars (\$140,000.00)</u>.

All other terms and conditions of BOS Agreement No. <u>16-083</u> shall remain in full force and effect.
