AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. PA 14-76, PA 16-27A1, PA 16-110A2, PA 17-29A3

This Amendment to Agreement No. PA 14-76 is entered into this The day of Denver, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and REDWOOD TOXICOLOGY LABORATORY, INC., hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 14-76 was entered into on September 1, 2014; and

WHEREAS, Agreement No. <u>PA 14-76</u> was amended on <u>September 1, 2015</u> to extend the expiration date to August 31, 2016 (PA 16-27A1); and

WHEREAS, Agreement No. <u>PA 14-76</u> was amended on <u>June 1, 2016</u> to increase the annual dollar amount from \$35,000.00 to \$50,000.00 (PA 16-110A2); and

WHEREAS, Agreement No. <u>PA 14-76, PA 16-27A1</u> was amended on <u>August 30, 2016</u> to extend the expiration date to August 31, 2017 (PA 17-29A3); and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in Agreement No. <u>PA 14-76</u>, <u>PA 17-29A3</u>, from <u>August 31</u>, 2017 to <u>August 31</u>, 2018; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in Agreement No. <u>PA 16-110A2</u>, from <u>Fifty Thousand Dollars</u> (\$50,000.00) to <u>One Hundred Seventy Four Thousand Four Hundred Thirty Two Dollars</u> (\$174,432.00).

WHEREAS, Agreement PA 14-76 allowed 3 one time one year extensions. With the approval of this amendment there will no further extensions available.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in Agreement No. PA 17-29A3 will be extended from

- August 31, 2017 to August 31, 2018.
- 2. The total contract amount set out in Agreement No. <u>PA 16-110A2</u> will be increased from <u>Fifty Thousand Dollars (\$50,000.00)</u> to <u>One Hundred Seventy Four Thousand Four Hundred Thirty Two Dollars (\$174,432.00).</u>

All other terms and conditions of Agreement No. <u>PA 14-76, PA 16-27A1, PA16-110A2, PA 17-29A3</u> shall remain in full force and effect.
