

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. PA 14-76, PA 16-27A1, PA 16-110A2, PA 17-29A3**

This Amendment to Agreement No. PA 14-76 is entered into this 17th day of October, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and REDWOOD TOXICOLOGY LABORATORY, INC., hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 14-76 was entered into on September 1, 2014; and

WHEREAS, Agreement No. PA 14-76 was amended on September 1, 2015 to extend the expiration date to August 31, 2016 (PA 16-27A1); and

WHEREAS, Agreement No. PA 14-76 was amended on June 1, 2016 to increase the annual dollar amount from \$35,000.00 to \$50,000.00 (PA 16-110A2); and

WHEREAS, Agreement No. PA 14-76, PA 16-27A1 was amended on August 30, 2016 to extend the expiration date to August 31, 2017 (PA 17-29A3); and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in Agreement No. PA 14-76, PA 17-29A3, from August 31, 2017 to August 31, 2018; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in Agreement No. PA 16-110A2, from Fifty Thousand Dollars (\$50,000.00) to One Hundred Seventy Four Thousand Four Hundred Thirty Two Dollars (\$174,432.00).

WHEREAS, Agreement PA 14-76 allowed 3 one time one year extensions. With the approval of this amendment there will no further extensions available.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in Agreement No. PA 17-29A3 will be extended from

August 31, 2017 to August 31, 2018.

2. The total contract amount set out in Agreement No. PA 16-110A2 will be increased from Fifty Thousand Dollars (\$50,000.00) to One Hundred Seventy Four Thousand Four Hundred Thirty Two Dollars (\$174,432.00).

All other terms and conditions of Agreement No. PA 14-76, PA 16-27A1, PA16-110A2, PA 17-29A3 shall remain in full force and effect.
