RE: ADOPTION OF RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS DECLARING ITS INTENTION TO CONSIDER ROAD NAME CHANGE PETITION NUMBER 17-01 AND SUMMARY ROAD VACATION PETITION NUMBER 17-01 OF COUNTY ROAD 141, COX SCHRADER ROAD (FRONTAGE ROAD E), (UKIAH AREA)

Honorable Board Members:

The Department of Transportation (DOT) has received and reviewed Road Name Change Petition Number (No.) 17-01 and Summary Road Vacation Petition No. 17-01 of County Road (CR) 141, Cox Schrader Road (Frontage Road E), finding them to be compliant with the requirements for road name change and summary vacation of a road. The petitions have been signed by the appropriate number of supporting Mendocino County residents, the filing fees have been paid, and all supporting documents have been submitted.

The Petitioners wish to change the name of State Highway 101 Cox Schrader Exit 545 to Rivino Ranch Road, but per California Department of Transportation (Caltrans) instruction, they must first have CR 141, Cox Schrader Road (Frontage Road E), changed to the desired name. The petitioners have therefore submitted a petition to change CR 141, Cox Schrader Road (Frontage Road E), to Rivino Ranch Road. After the name has been changed the petitioners are also requesting the County to vacate said road so that for their security they may gate it. Road Vacation Petition No. 17-01 meets the requirement to be considered as a summary road vacation pursuant to California Streets and Highways Code Section 8334 which provides "a portion of a street that lies within property under one ownership and that does not continue through such ownership or end touching property of another."


A map of the area impacted by the proposed name change and summary road vacation is attached for your review.

DOT recommends that it is now appropriate for the Board to declare its intention to consider

Road Name Change Petition No. 17-01 and Summary Road Vacation Petition No. 17-01 of CR 141, Cox Schrader Road (Frontage Road E), and direct the Clerk of the Board to administratively schedule a Public hearing on the matter for a future date, and direct staff to compile data and prepare applicable reports for consideration at the hearing.
