#### 2988-17 10-20/17 ORDINANCE NO. 4395

AN ORDINANCE AMENDING DIVISION III OF TITLE 20 OF MENDOCINO COUNTY CODE (OA 2013-0001)

It is proposed to adopt substantial changes to the Mendocino Town Zoning Code (Division III of Title 20 of the Mendocino County Code). While most sections of the zoning code have been amended, topics that have been substantially modified include, but are not limited to, definitions, visitor serving facilities, environmentally sensitive habitat areas, secondary residential units in certain zoning districts, demonstration of adequate water supply, stormwater, certain zoning district changes, and changes related to principally permitted, permitted and conditionallypermitted uses.
