AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 16-051

This Amendment to BOS Agreement No. 16-051 is entered into this _____ day of ______, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Belfor Property Restoration, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-051 was entered into on June 27, 2016; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>Belfor Property Restoration</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to alter the scope of work set out in the original BOS Agreement No. 16-051 to include the replacement of roofing over the "new storage" area located at 400 E. Commercial St. in Willits and to cover necessary flashing repairs over the Long Gallery area, classrooms 1-3; and

WHEREAS, the original amount set out in BOS Agreement No. 16-051 will be increased from Six Hundred Thousand Dollars (\$600,000) to Eight Hundred Forty Four Thousand Eight Hundred Ninety Two Dollars and Twenty Six cents (\$844,892.26).

NOW, THEREFORE, we agree as follows:

- 1. The scope of work set out in the original BOS Agreement No. 16-051 will include the replacement of roofing over the "new storage" area located at 400 E. Commercial St. in Willits and to cover necessary flashing repairs over the Long Gallery area, classrooms 1-3.
- 2. The compensation payable to CONTRACTOR shall be increased by Two Hundred Forty Four Thousand Eight Hundred Ninety Two Dollars and Twenty Six cents (\$244,892.26) for a new not to exceed amount of Eight Hundred Forty Four Thousand Eight Hundred Ninety Two Dollars and Twenty Six cents (\$844,892.26).

All other terms and conditions of BOS Agreement No. <u>16-051</u> shall remain in full force and effect.
